2.1. Purpose, legal basis, categories of recipients and storage time of data processing

The purpose of the data processing on this website is the information about the products and services of our company, combined with the possibility of users being able to contact the relevant person within the company.

We also process personal data according the following legal base:

- › Article 6 (1) lit. A GDPR for the processing of personal data with the consent of the person involved.
- › Article 6 (1) lit. B GDPR for the necessary processing of personal data in order to fulfil a contract with the person concerned and to carry out appropriate pre-contractual measures.
- › Article 6 (1) lit. C GDPR for the required processing of personal data in order to comply with a legal obligation which we are subject to, in accordance with any applicable law of the EU or according to any applicable law of a country in which the GDPR is wholly or partially applicable.

- ▶ Article 6 (1) lit. F GDPR for the required processing of personal data in order to protect the legitimate interests of us or third parties, unless the fundamental freedoms and fundamental rights and interests of the person concerned outweigh. Legitimate interests are in our personal business interest to be able to provide our website information security, enforcement of our own legal requirements and compliance with other legal provisions. The applicable law of a country in which the GDPR is wholly or partially applicable.

2.2. Purpose, legal basis, categories of recipients, storage time of data processing

In connection with the provision of services, we use special service companies, which are obligated to secrecy and to data protection. A transfer to authorities shall be carried out exclusively in the case of priority legislation.

When you visit the website, a connection is made with your browser. The information collected below is temporarily stored and automatically collected by system files: The IP address of your device, the date and time of access, the name and URL of the retrieved files, the website from which access is made or from Page (referrer URL), browser used and, if applicable, the operating system of your device and the name of your provider.

This data is processed for the purpose of smooth connection and system security. The connection data that is generated is automatically deleted which is usually for a maximum of seven days. If the website is used in an abusive manner, the log data is further stored which is required for evidence and will be removed until the incident has been clarified.

We use the YouTube channel for uploading videos on the website (legal basis according to GDPR: article 6 para 1 lit. f with the operation of our website and considering the interests of the interested parties by disabling the tracking functions in the YouTube code).

We use Google Analytics to analyze user behaviour. In addition, we use Google Maps, the tag manager and Google web fonts via fonts.gstatic.com as well as Google awesome fonts.

Google LLC in the United States is committed to providing adequate data protection in accordance with the American-European privacy shield. More information can be found in the Google's detailed privacy statement.
